The Fund also reported Net Profit of Tk. 19.57 crore, Earnings Per Unit Tk. 1.21 and Net Operating Cash Flow Per Unit Tk. 1.13 for the year ended June 30, 2017 (versus Tk. 9.33 crore, Tk. 0.58 and Tk. 0.63 respectively for the previous year).
